**NOTE:** Recommendations of all reviewing agencies, county and state offices, school districts, fire districts, tribes, etc., must be received by the Department of Community Development no later than fourteen (14) days prior to the hearing. Applications will be forwarded to these agencies promptly upon receipt by DCD of a complete application.
