PHYSICAL REQUIREMENTS: CONSTRUCTION INSPECTOR 1 AND 2
CONSTRUCTION INSPECTION SUPERVISOR

Positions in this class typically require:

- Walking short and long distances while maintaining balance on sometimes uneven surfaces
- Climbing and descending ladders and stairs
- Bending, stooping, twisting
- Squatting, crawling and kneeling in spaces with limited head room
- Reaching above and/or below shoulder height
- Exposure to heights, including buildings, roofs, and structures
- Climbing and walking on scaffolding
- Traversing rough, uneven, and undeveloped terrain
- Handling/grasping documents or equipment
- Sitting and/or standing for short or extended periods of time
- Clear speaking and adequate hearing sufficient to communicate effectively and respond appropriately in-person and/or on the telephone
- Hearing audible signals, traffic, and equipment
- Vision sufficient to read source materials, meters, gauges, computer screen data, and see detail or color
- Repetitive motions for computer, tools and equipment use
- Requires exertion of force of 20 pounds occasionally, 10 pounds frequently to lift, carry or move office and field equipment and other materials
- **Some positions may require exertion of force of up to 75 lbs. occasionally and 100 lbs. with assistance to lift/carry/move objects.**
