## SPECIAL DEPARTMENT RULES

1. Removal of any exhibit, prior to dismissal time, from display area will be seen as a final act and will result in immediate forfeiture of all premiums and privileges by the exhibitor. Further, exhibitor may be suspended from future exhibiting at the Kitsap County Fair.
2. All health requirements will be strictly enforced.
3. Total entries will be limited to 500 rabbits due to space restrictions, as well as State Regulations.
4. Entry deadline for Open show is August 15<sup>th</sup> or earlier. Entries will be accepted on the basis of first come, first served and will be accepted on the basis of space available.
5. All entries must be permanently earmarked.
6. This show will be judged, operated and sanctioned in accordance with ARBA rules and standards.
7. Rabbits will be released following judging on Wednesday for day show entries.
8. Judging will be as near 9:00 a.m. as possible.
9. Where there is no competition, the judge may, in his/her judgment, award 2<sup>nd</sup> premium in place of 1<sup>st</sup>.
10. No doe and litter accepted for entry.
11. All rabbits will be judged in the class written on the entry blank. Make out entry carefully. Be sure to include Breed, Variety, Class, Sex and Ear Number.
12. The exhibit is being entered at the sole risk of the owner. The greatest possible care will be given to all exhibits. The Fair is not responsible for any accidents.
13. All rabbits entered in Fur classes must be entered in Open Class. Rabbits disqualified in type may not be shown in Fur Class.
14. Entry fees are:  
\$1.50 for singles  
\$1.50 for fur and wool class
15. Entry fees must be paid when entries are submitted. Check should be made out to Kitsap County Fair.

17. Rabbits left for 5 days at Fair will be released no earlier than 6:00 p.m. Sunday.

21. All open day of show entries must be Vet checked before they can be judged. The Vet Check will be from 7:00 a.m. – 8:30 a.m.
22. No email entries accepted. No return of entry fees.
23. No vehicles are allowed on the Fairgrounds after dark. The Fairgrounds will be open from 6:00 a.m. to 9:30 a.m. for dropping of rabbits. Enter through the lower arena gate and exit the same way. Depart no later than 9:30 a.m. or your vehicle may be towed off the grounds.
