

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Kitsap County Board of Commissioners will hold a public hearing on **June 18, 2007** beginning at the hour of **10:05 a.m.**, in its Chambers, County Administration Building, 619 Division Street, Port Orchard, Washington 98366 to consider an **Ordinance** setting speed limits on **Hansville Road NE** and further described as follows:

WHEREAS, RCW 46.61.415 provides that the Local Authority may determine and declare reasonable and safe maximum speeds, and

WHEREAS, on the basis of an engineering and traffic investigation, the Department of Public Works has determined maximum speed limit on various sections of Hansville Road NE,

NOW, THEREFORE, BE IT ORDAINED by the Board of Kitsap County Commissioners, in regular session assembled, that it is the intention of said Board, in the interest of public safety, to have certain regulatory speed limit signs erected as follows:

Hansville Road NE, beginning at SR #104, for a distance of 1505 ft. (.285 miles) north, located in Sections 21 and 22, Range 2 East, Township 27 North, W. M., the speed limit shall be 35 mph.

Hansville Road NE, beginning 1505 ft. north of SR #104, and ending 500 ft. north of Old Hansville Road NE (south intersection) for a distance of 12758 ft (2.416 miles) north, located in Sections 9, 10, 15, 16, 21, and 22, Range 2 East, Township 27 North, W. M., the speed limit shall be 45 mph.

Hansville Road NE, beginning 500 ft north of Old Hansville Road NE (south intersection), for a distance of 21570 ft. (4.085 miles) to Hansville Drive NE north, located in Sections 3, 4, 9, and 10, Range 2 East, Township 27 North, W. M., and Sections 21, 22, 27, 28, 33 and 34, Range 2 East, Township 28 North, W. M., the speed limit shall be 50 mph.

Hansville Road NE, beginning at Hansville Drive NE (south intersection) to Point No Point Road NE, for a distance of 3500 ft. (.663 miles) north, located in Sections 16 and 21, Range 2 East, Township 28 North, W. M., the speed limit shall be 35 mph.

Hansville Road NE, beginning at Point No Point Rd NE to NE Twin Spits Road, for a distance of 891 ft. north, located in Section 16, Range 2 East, Township 28 North, W. M., the speed limit shall be 25 mph.

BE IT FURTHER ORDAINED that this order shall supersede any ordinances to the contrary that may have been passed previously and shall take effect immediately.

ALL THOSE INTERESTED are welcome to attend. **(Please note that hearing start times are estimates and may be impacted by the amount of public input).**
