Sheriff's detectives track kidnapping suspects

Port Orchard, Wash. -- Kitsap County Sheriff's detectives are looking for two suspects, a man and a woman, for their involvement in the assault, robbery and kidnapping of a 26 year-old East Bremerton woman 11 days ago.

Wanted are Kevin Dean Page, age 40, and Charlotte Ann Warfel, age 36. A warrant of arrest for kidnapping was issued out of Kitsap County Superior Court on July 17 for both suspects.

Shortly before 1:00 a.m. on Sunday, July 16, the victim was assaulted in her home in East Bremerton, tied up with rope and gagged with packing tape by three persons known to her: a man and two women. The victim was then dumped into the trunk of her own vehicle, a Hyundai Accent.

While the suspects drove her vehicle the victim managed to free herself, pull the interior trunk release mechanism and escape. The victim sustained a head injury and numerous other lacerations and bruises from her ordeal. Her Hyundai Accent was found five hours later in the Seabeck area of West Central Kitsap, abandoned and fully engulfed by fire.

One of the three suspects, Michelle Lee Ramsey (AKA Manchester), age 36, was arrested that evening by Sheriff's detectives at a residence in Mason County. She is presently being held in Kitsap County Jail on charges of kidnapping and robbery, 1st degree, with bail set at \$100,000.

Both Page and Warfel have ties to Kitsap, Mason and Pierce Counties, but have no identifiable means of financial support. They were last seen in Pierce County.

Detectives believe that the two are possibly using a dark blue 1998 Jeep Cherokee, license 255-PAF (WA), for primary transportation. The Jeep has been reported stolen out of Mason County. Warfel's vehicle, a 1980 Datsun, was found July 25 by local law enforcement authorities abandoned in the parking lot of a Puyallup Safeway Store.
