Burglary gang update: one additional suspect arrested, three more wanted

Kingston, Wash. -- Kitsap County Sheriff's detectives and patrol deputies continue with their investigation into the high volume of property crimes that have victimized residents of all communities within North Kitsap.

A 19 year-old Central Kitsap man is the most recent person charged in connection with these crimes. Detectives arrested Shawn M. Jessep II, of Silverdale, just before 5:00 p.m., Monday, at a residence in the 1300 block of NW Hogan Lane. Jessep was charged in Kitsap County Superior Court, Tuesday, with burglary, 2nd degree and possession of stolen property, 1st degree. Jessep remains in jail with bail set at \$30,000.

As this point in the investigation, sheriff's detectives have obtained warrants of arrest for three suspects, still at large, who are alleged to be involved in the burglaries and thefts (see pages 2 – 4 of this news release).

Additionally, detectives have finished photographing, compiling and cataloging all of the items of stolen property, that have so far been recovered during the course of search warrants served at various locations.

Victims must have filed a police report, when their property was discovered stolen, in order to view the catalogue.
